



NQBP coal exports







TMR Priority port master planning



- Department of Transport and Main Roads (TMR) continues to lead priority port master planning for North Queensland port of Hay Point/Mackay.
- Final master plan is currently being prepared.
- Due to be released late 2023.
- In August 2023, TMR Minister Bailey announced the turtle habitat at North Harbour Beach will be determined as environmentally significant and will be protected.

Port of Mackay - powering on

Last financial year results

- 3.51Mt just shy of last year's record (3.59Mt)
- Annual report released with full data

This financial year to date

Over 1Mt throughput in the first quarter of the 2023/24, a first for the port.

Combination of:

- High sugar exports (335,000 tonnes)
- High grain exports (139,000 tonnes)
- Strong fuel trade (550,000 tonnes)



Bumper month of break bulk



- October 2023 marked a bumper month for break bulk.
- Major shipment for Hastings Deering and world-leading OEM Caterpillar (CAT).
- 38 disassembled CAT machines.
- Weighing in at more than 3,000 tonnes.
- Offloaded through more than 435 lifts.
- Included dozers, wheel loaders, graders and dump trucks.





DUKC Mackay / Hay Point



DUKC celebrates 30 years at Hay Point and a future at Mackay

- 30-year anniversary of Dynamic Under Keel Clearance (DUKC®) at Port of Hay Point.
- DUKC® calculates the under-keel clearance of each ship in real-time as it transits through a channel, using ship modelling and real-time tidal information.
- Benefits:
 - Increased sailing drafts and sailing windows while reducing navigational risk.
 - Optimises port throughput
 - Prevented groundings
 - Reduced dredging, fuel use and greenhouse gas emissions
- 185,000 transits optimised since 1993.
- DUKC recently approved for Mackay.

Inner Northern Breakwater rehabilitation

Status: Project underway

- Rehabilitation of 330 metre section of inner Northern Revetment (breakwater).
- Repairs damaged cause by wave action and weather events over decades.
- Works will ensure the breakwater continues to protect key port infrastructure into the future.
- Local Mackay contractor: Vassallos
- Completion expected in early 2024.
- Budget: ~\$4 million.



A temporary causeway has been built to facilitate the Northern Revetment repairs.

Port projects



Wharf 5 electrical upgrade

Status: Project underway

- Replacement of electrical infrastructure supplying Wharf 5.
- Includes new cabling, cable trays, junction boxes and a cathodic protection transformer.
- Local Mackay contractor: RGB Industries
- Completion in early 2024.
- Budget: ~\$750,000.

Port Binnli / Mackay Marina nib wall



- Works on Port Binnli's Mackay Marina nib wall are complete.
- Official 'opening' for nib wall scheduled for December.

Southern Breakwater



- Full access to NQBP's Southern Breakwater has been reinstated.
- NQBP encourages the community to access and use the breakwater in a safe and responsible manner.
- Asking community to have consideration of other users and local residents of the Mackay Marina.
- Any unsafe or illegal behaviours should be reported to Queensland Police Service on Policelink 131 444.
- NQBP will monitor noise, traffic and complaints as part of a broader public safety, amenity and access review.

Climate and ESG




- 2015 NQBP's first sustainability plan

- Appointed a new Specialist Sustainability and ESG – Renee McGlashan
- First steps benchmarking, gaps, and materiality assessments
- Looking for small wins to begin



North Wall beach erosion



- NQBP has sought further advice from Department and Science (DES) on previous ad-hoc practices of sand placement.
- No approvals in place to allow renourishment practices.
- Tidal works applications are required.
- Shoreline Erosion Management Plan (SEMP) is required by State to consider any tidal work applications.
- NQBP's strategic port land ends at high water mark.
- However, while NQBP has no delegated authority over beach management, we will engage an expert consultant to undertake necessary studies to support a SEMP.
- Will include gathering of historic information and engagement with Mackay and District Turtle Watch.






