





#### **NQBP** coal exports









## Pilotage – Port of Hay Point



#### Pilotage team goes from strength to strength

- Two Trainee Pilots now licenced for Port of Hay Point
- > Three months training in addition to previous experience and Master Class Level 1 tickets.
- Achieved Pilot Licence and Hay Point Level 3 (vessels up to 230m LOA)
- Join team of 18 Pilots trained at Hay Point Level 1
- Extensive mentoring and a combined 137 movements during training.
- Theoretical and practical training, simulation training, Regional Harbour Master exams, model ship training at Port Ash and more.





## Celebration for DUKC 30<sup>th</sup> year anniversary



- Event to celebrate 30-year anniversary of Dynamic Under Keel Clearance (DUKC®) at Port of Hay Point next month
- DUKC® calculates the under-keel clearance of each ship in real-time as it transits through a channel, using ship modelling and real-time tidal information
- Benefits:
  - Increased sailing drafts and sailing windows while reducing navigational risk.
  - Optimises port throughput
  - Prevented groundings
  - Reduced dredging, fuel use and greenhouse gas emissions
- 185,000 transits optimised since 1993
- DUKC recently approved for Mackay








