CRG PURPOSE




"To inform the decision-making of NQBP through providing an advisory and consultative role"

HAY POINT ADMINISTRATION BUILDING UPGRADE



- Jan 2021 Refurbishment works began.
- Ground floor and partial first floor works complete.
- VTS area refurbishment commencing soon.
- Completion expected end of August (weather permitting).
- Key stakeholders will be kept informed of any updates.



HOUSING AND MAINTENANCE PROGRAM UPDATE





- NQBP will soon call for tenders for the demolition of some of its aged and/or vacant properties.
- Seven properties have been inspected and deemed not viable/meeting liveability requirements.
- Demolition works are expected to take place in the new financial year.
- Works will be conducted in accordance with Work Health and Safety regulations.
- Public access to surrounding properties is not expected to be impacted by the demolition works.
- Environmental management measures will also be in place throughout the works to ensure the protection of the environment.
- The demolition works will be carried out utilising the use of heavy machinery and manual tools.
- Works will be conducted on weekdays only.
