

Inner Northern Breakwater rehabilitation

Status: Tender awarded, construction in August.

- Rehabilitation of 330 metre section of inner Northern Revetment (breakwater).
- Repairs damaged cause by wave action and weather events over decades.
- Works will ensure the breakwater continues to protect key port infrastructure into the future.
- Local Mackay contractor: Vassallos
- Completion expected by end of 2023.
- Budget: ~\$4 million.



Current condition of the inner Northern Breakwater.



Middle Breakwater common user pipeline support replacement

Status: Tender to be awarded after lease negotiations completed.

- Relocation of fuel, ethanol and water pipe infrastructure.
- Provides greater resilience against storm and cyclone exposure.
- Unlocks area to the West of Wharf 1 for future development.
- Completion expected by end of FY23.
- Budget: ~\$9 million.

Wharf 5 electrical upgrade

Status: Second round tender review

- Replacement of electrical infrastructure supplying Wharf 5.
- Includes new cabling, cable trays, junction boxes and a cathodic protection transformer.
- Tender readvertised, closed 13 June.
- Tender assessments underway.
- Completion by end of 2023.
- Budget: ~\$750,000.





Port Binnli / Mackay Marina nib wall



- Works on the Mackay Marina nib wall continue.
- NQBP has given control of the Southern Breakwater to Port Binnli and Halls Contracting.
- Construction started early March.
- Works expected to be completed by end of September, weather dependent.
- Community events have been held as normal.
- Pedestrian access remains after hours and on weekends.
- Mackay Marina handling communication and public enquiries.

Mt Bassett closure – BOM radar replacement



- BOM are replacing the Mackay weather radar at Mt Bassett.
- Access to NQBP's Mt Bassett lookout has been closed to the general public for the duration of the works.
- Works began in May 2023.
- Works expected to be completed by end of 2023.



Access to NQBP's Mt Bassett lookout is restricted due to BOM's radar replacement works.






