Sale of NQBP airport land



- NQBP intends to sell two non-strategic parcels of land (legacy from previous airport ownership).
- The land was originally part of Leprechaun Park/Brothers Football Club.
- NQBP honoured a previous commitment to the Mackay Regional Council and made a \$1 million contribution towards the relocation of the sporting fields in 2014.
- Multiple offers have been received, with strong interest in the land given its proximity to key Mackay commercial precincts. Best and final submissions are now being sought.




Importance of Port of Hay Point to the Local Economy

Frequency of Using the Ports



Top Five (5) Most Important Priorities



Level of Concern with Impacts of Port Activities




Top Five (5) Concerns Related to Port Activities
