






CRGS - TERMS OF REFERENCE FINALISED


PORT OF HAY POINT






PORT OF MACKAY







TRADE PERFORMANCE



- August Port of Mackay successfully handled the shipment of BMA's dismantled Hay Point Coal Terminal trestle and conveyor - more than 300 containers weighing 6,000 tonnes.
- September \$17M in projects announced for Mackay and Hay Point:

Mackay

- A new tug berth facility
- Upgrades to Wharves 1 and 4
- Revetment stabilisation works
- Maintenance dredging

Hay Point

- Refurbishment of Hay Point administration building that houses Vessel Traffic Services.
- October Port of Mackay facilitated the delivery of 10 new Caterpillar trucks for Hastings Deering (pictured right), which were transported from Texas via Hoegh Autoliners.

HAY POINT ADMINISTRATION BUILDING UPGRADE



- September NQBP called for tenders for upgrade of Hay Point Administration Building via QTenders.
- November NQBP to announce awarded contract and works to commence.
- Works will include refurbishment and upgrade of the interior fit outs and utilities.
- Duration of works approx. 9 months (weather permitting).
- Key stakeholders will be kept informed of any updates.




Hay Point Administration Building – aerial view.

HAY POINT BED LEVELLING



- July Hydrographic surveys were conducted at Port of Hay Point and Half Tide Tug Harbour.
- October November Bed levelling works were conducted at Port of Hay Point (departure channel and apron), and Half Tide Tug Harbour (berths and channel).

Items you should have:


- An emergency plan (at work and home)

JCU PARTNERSHIP



- Partnership extended in October and will introduce the use of advanced technologies

 i.e. remote camera systems, artificial intelligence, remote operated vehicles, and improved sensors and data loggers.
- Scholarships are now offered for undergraduate and postgraduate marine science students to work on science relevant to the port industry.
- We are continuing our intern program with 13 applicants for the most recent round of expressions.
- NQBP Environment team provided virtual lecture to JCU marine science students in October as part of an ongoing lecture program.

RECONCILIATION ACTION PLAN

CORAL DASHBOARD



- NQBP has monitored coral within the Great Barrier Reef World Heritage Area with JCU since 2006.
- This program spans across six inshore islands and researchers dive and record coral health over an area stretching 6km each year.
- NQBP's new coral dashboard will be published to its website before the end of 2020.
- New Water Quality Dashboard now being developed.
- Annual reports are also available on the NQBP website.



SEAGRASS REPORT



- The 2019 annual seagrass monitoring data is now available on the NQBP website.
- Inshore seagrass remains sparse, but where it is present it is very dense.
- Offshore seagrass coverage is above 30% (up from 10% on the previous year) and at the highest density we have seen in the last 10 years.
- The full 2019 report is available on the NQBP website.

MACKAY MAINTENANCE DREDGING



- NQBP will undertake maintenance dredging at the Port of Mackay in early December 2020.
- Delayed due to vessel availability.
- First-time maintenance dredging has been conducted at the Port of Mackay since 2013.
- Dredging will take up to fourteen days.
- NQBP has the State and Commonwealth maintenance dredging permits for the Port of Mackay.
- NQBP staff and contractors will be working within these permits which outline strict environmental conditions.
- Communications and engagement plan will be rolled out with support from Volunteer Marine Rescue and Mackay Marina.

SWIMMING SUPPORT BOOST AT ALLIGATOR CREEK
